**Subject:** Maharashtra University of Health Sciences, Nashik - Recognition of MD(Pharmacology) qualification for 2 seats in respect of students being trained at Government Medical College, Akola.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 07/09/2017 considered the Council Assessor's Report (11th July, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Pharmacology) qualification for 2 seats at Government Medical College, Akola granted by Maharashtra University of Health Sciences, Nashik and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (11th July, 2017) and decided to recommend to the Central Government that MD(Pharmacology) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Government Medical College, Akola be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
